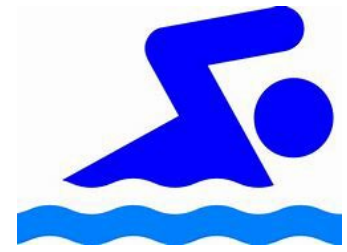




# PRIVATE SWIM LESSONS
